



City Ice Pavilion LLC Guest Coach Agreement Effective 7/1/2021-6/30/2022

- All guest coaches must have a **Certificate of Insurance** naming City Ice Pavilion as additionally insured. A current copy of the insurance certificate must be kept on file (send to skateschool@cityicepavilion.com).
- All guest coaches must have up to date SafeSport certification, CERs and compliance. Proof of this certification must be kept on file (send to skateschool@cityicepavilion.com).
- **Guest coaches must sign in and pay their commission fee (equivalent to the price of ice time)**, before entering the ice. Session registration limits will not be waived to accommodate guest coaches.
- Guest coaches must abide by all SafeSport guidelines, the USFS/PSA Code of Ethics, all facility rules, and the freestyle etiquette and traffic flow charts on the City Ice Pavilion website.
- Solicitation is not permitted at City Ice Pavilion and will result in loss of guest coach privileges.
- Guest coaches charge their own private lesson fees.
- Guest coaches are not permitted to use the Figure Skating Coaches room without expressed authorization, including storage of personal equipment.
- Guest coaches are permitted to teach on Freestyle (level permitting), Stick and Puck (hockey only), Coffee Club (adult students only), Coaches' Ice (beginner students only) and Studio Rink (via online rental) sessions. Guest coaches are not permitted to teach lessons on Public Sessions or Studio Ice Coaches' Ice.
- No more than 2 skaters are permitted in a semi-private lesson. Coaches are not permitted to run classes or academy style training for more than 2 students at a time on any session.
- Guest coaches are not permitted to hold off ice lessons or classes.
- Coaches are responsible for educating customers on admission fees and cancellations. City Ice Pavilion will not refund customer or coach admission if a lesson is canceled.
- This agreement may be terminated upon breach of any given term or condition.

All independent coaches are deemed to be independent contractors and nothing contained in this agreement shall be construed as, or have the effect of, creating or constituting a relationship of employer and employee between the parties to this agreement. I have read all of the material on this page, I fully understand the City Ice Pavilion Independent Coaches Agreement, Freestyle Session Etiquette Packet, and the USFS and PSA Code of Ethics, and I am in agreement with all that I have read.

I enter City Ice Pavilion at my own risk and hereby release City Ice Pavilion, their officers, directors, instructors, and personnel or all liability. I declare that the above information is true. I hereby grant and give City Ice Pavilion the right to use my photograph with or without my name, both singular and in conjunction with other persons and objects for any and all purposes.
